

Terms and Conditions of Competition Entry – Off-Road Safari in Namibia, Africa

1. Organizer

The joint organizers of the competition are **Continental Reifen Deutschland GmbH**, Vahrenwalder Str. 9, 30165 Hanover, Germany ("Continental") and **Delticom AG**, Brühlstraße 11, 30169 Hanover, Germany ("Delticom").

2. Eligibility for entry

Entry is open only to adults with a valid driver's license for passenger cars and at least one year's driving experience who have purchased at least one "Continental" brand tire from this website during the promotion period and who have fully and correctly completed the specified online input fields. Since the prize is an off-road safari, entrants must also be in good physical condition. Employees of Continental and Delticom are excluded from the competition. Entrants are responsible for ensuring that their personal and contact details are correct; in particular, their e-mail and postal addresses. By entering this competition, entrants accept these terms and conditions of entry. Only one entry to the competition per entrant is permitted.

Based on the fact, it is an off-road safari in South Africa and the participants of the Prize Draw come from many EU countries, all the participants must have sufficient language skills of English, which enables a common understanding with other participants and the support team too. The organisers reserve the right to check the language skills isolated and if necessary to refuse entries prior the beginning of the travel to Namibia. The participant agrees that in the event of the exclusion due to insufficient language skills, he/she is not entitled to any claims for reimbursement of costs incurred. Also the organizers are not obliged to pay any compensation in event of non-commencement of the journey based on the exclusion.

3. Promotion dates

The promotion runs from March 1, 2015 to March 31, 2015.

4. Prizes

The following prize will be awarded by means of a prize draw among all entrants:

One trip to Namibia for one person with an off-road safari, including flight from Frankfurt (including feeder flight to Frankfurt from the participating country), accommodation and catering from June 8, 2015 to June 14, 2015.

The prize draw will be conducted by Delticom. Prizes cannot be returned, nor can they be transferred or redeemed for cash. The winner is responsible for his/her own physical condition. The organizers assume no responsibility for the physical condition of the winner when the prize is collected.

5. Notification of winner

The winner will be notified promptly by e-mail following the prize draw. As part of the competition, Continental and Delticom are entitled to send the winner's information to cooperation partners to enable notification and delivery of the prize. If the winner does not contact Delticom within one week of being notified, his/her prize claim will be forfeited without

replacement. The dates of travel are fixed. In other words, the prize will likewise be forfeited without replacement if the winner cannot travel on the dates specified above.

6. Travel prize arrangements

The travel prize will be arranged exclusively by means of direct contact between the winner and the cooperation partner or a travel agent acting on behalf of the latter. There is no entitlement to a particular date of travel. If the trip does not take place on the date or during the period specified by the cooperation partner or travel agent, there is no longer any entitlement to the prize. By confirming participation in the trip, the winner agrees to be subject to the terms and conditions of the travel agent. Travel to and from the departure point for the trip (airport, station, etc.) will be at the winner's expense, unless otherwise stipulated in the competition or expressly agreed. The same applies to all costs incurred during the trip (minibar, telephone, etc.). The value of the trip refers to the most expensive time of travel and is thus subject to seasonal variations and currency fluctuations, depending on the time at which the trip is made available and used. There will be no compensation for any such difference in value.

The participation in this drawing may have tax consequences for the winners, depending on the law of their state of residence. Continental expressly excludes any tax liability and cannot be held liable by the winners for any of such tax consequences.

7. Abuse

In the event of any suspicion that chances of winning have been compromised by manipulation or other improper or unfair means, Continental and Delticom reserve the right to exclude entrants from this competition, deny or reclaim prizes previously awarded and declare a replacement winner.

8. Liability limitation

Continental and Delticom are not liable for technical faults, particularly failures of the network, electronics or computers. Continental and Delticom reserve the right to break off or terminate the competition at any time without prior notification and without giving reasons. Continental and Delticom are not liable for insolvency of the cooperation partner and the resultant consequences for performance of the competition and arrangement of the prize. Furthermore, Continental and Delticom are liable only for damages caused by intent and gross negligence or by the violation of material contractual obligations. This does not apply to damage or injuries to life, limb or health. Recourse to the courts is not permitted.

9. Data protection:

Entrants are required to register personally to participate in the competition. Registration may not be performed by a third party. By registering, entrants declare their express consent for Continental and Delticom to store the data necessary to conduct the competition for the duration of the competition and to transfer it to the cooperation partner for the purpose of conducting the competition and arranging the prize. The cooperation partner may likewise store the personal data for the duration of the competition. Unless entrants expressly confirm otherwise, the information provided as part of this competition is used only for the purpose of conducting the competition and is subsequently deleted. It may not be forwarded to third parties without express permission. Furthermore, entrants declare their consent for their name to be published by Continental or Delticom or a company affiliated with these companies in the event that they win. 10. Pictures rights

In connection with the safari the (co-)organiser Delticom AG plans to take pictures and / or conduct interviews and / or shoot movies (hereinafter referred to as recordings) of the participants by a professional photographer / film crew using it for marketing purposes. Certified herewith the owner entitles the Delticom AG and its affiliated subsidiaries an exclusive right to use the contractual recordings. The right of use includes all known commercial / non-commercial exploitation rights, particularly the right to change and dissemination of the recordings. It includes the right of renting. A spatial or temporal limitation does not exist. Delticom AG will use the contractual recordings exclusively under the herein defined forms of exploitation and pay attention to other personal rights of the participants.

11. Applicable law, place of jurisdiction

This competition is subject to German law. The place of jurisdiction is Hanover, Germany.
