

Competition participation conditions – World Cup 2018 predictor

1. Organiser

This promotion is organised by Delticom AG, Brühlstrasse 11, 30169 Hanover, Germany (hereinafter referred to as “Delticom AG”).

2. Prizes

The prizes are a VW up! worth € 12,000 (grand prize), a foosball table worth € 1,000 (1st prize), an iPhone 7 worth € 739 (2nd prize), and a BarrelQ Big Barbecue worth € 239 (3rd prize).

3. Conditions for participation

By participating in the prize draw, users accept the following terms and conditions. Participation in the prize draw is voluntary and free of charge. The participant may only take part in the draw in their own name, taking part on behalf of a third party is not permitted. The participant must be at least 18 years old, and participation is limited to legal persons. Those eligible to participate are commercial customers of the platforms named under No. 4. Customers may only register for the prize draw with their existing ARO account. Multiple registrations (e.g. through multiple email addresses belonging to the customer) are excluded. The prize may not be paid in cash, and any exchange, in whole or in part, is not permitted. The claim is not transferable/assignable.

4. Execution and processing of the prize draw

The competition will take place from 14 June 2018 at 00:00 until 15 July 2018 at 24:00 in the following shops:

To this end, participants must register via their B2B accounts with KickTipp, and enter their predicted results for the matches in the 2018 World Cup in Russia into the predictor provided.

All participants who play to the end of the competition, regardless of their finishing place in the predictor game, will be entered into the prize draw to win the grand prize of VW up!. The winner will be decided at random using a computer, and will be informed

of their win by Delticom. The prize does not include the costs associated with taxes, insurance, registration and transfer of the vehicle.

The rest of the prizes will be awarded based on performance in the predictor game. The winners will also be notified after the competition has ended. The first place winner will receive a foosball table in Delticom design, the second place winner an iPhone 7, and the third place winner a Barrel Q Big Barbecue.

Winners will be notified promptly by email after the prize draw or once the finishing positions are decided. If there is a tie in the overall score, then the number of daily wins will be taken into account. If there is still no clear result, the prizes will be decided by a prize draw. In the context of the prize draw, Delticom is entitled to transmit the winners' data to its cooperation partners in order to enable the notification of winners and the transfer of prizes. If the winner does not respond within 1 week after notification of their win by Delticom, then the claim for the prize expires without replacement.

Delticom AG reserves the right to amend, cancel or terminate the draw at any time, without prior notice, and without giving any reason. If proper conduct of the draw cannot be guaranteed for technical reasons (e.g. a virus in the computer system, manipulation, or an error in the hardware/software), or for legal reasons, Delticom AG reserves the right to immediate termination. The behaviour of a participant may lead to immediate termination of the draw, in particular retrospectively and/or evident lack of a participant's intent, if, for example, they are a member of so-called voting group, click community or similar, and they use this for support during their participation, and thus gain an advantage. If this is the case, Delticom AG may exclude a participant (also retrospectively). In cases of retrospective exclusion, the prize will be re-drawn amongst all participants.

Changes to the conditions of participation and cancellation of the draw will be communicated by Delticom AG via the participating internet sites and by email.

5. Data protection

To participate in the competition, personal registration by the participant in one of the shops mentioned in no. 4 or on Kicktipp.de is required. Registration may not be carried out by a third party. **By registering, the participant expressly agrees that Delticom may store the data necessary for the execution of the competition for the duration of the competition.** The data provided for this competition – unless expressly confirmed otherwise by the participants – will only be used for the purpose of carrying out the competition. It will then be erased, and will not be forwarded to third parties without explicit permission. **Incidentally, participants agree that, in the event of winning a prize, their name may be published by Delticom or a company affiliated with it.** Participants may at any time revoke the above declaration of consent to the storage of their data, request information on the data being stored about them, or request the erasure of their data, insofar as Delticom is not required by law to have the data available, by writing to

6. Liability; Third-party software

Any liability on the part of Delticom AG is restricted to intent or gross negligence. Delticom AG is not liable for any manipulation or interventions in the running of the draw or the predictor game on www. Kicktipp.de. This exemption from liability excludes injury to life, limb and health.

The operators are not liable for problems or technical malfunctions in telephone networks or connections, online network systems, server providers, computer hardware or software, emails and entries which affect the telephone network or a website due to technical problems or overloading the internet, or a combination of the events listed above. Furthermore, the operator is not liable for any damage to the participant's hardware or software caused by participation in the promotion and resulting from this participation. The operator is not liable for faults in, or damage to, the prize.

7. Exclusion from the competition

Employees of Delticom AG and associated/linked companies within the meaning of Section 15 Stock Corporation Act (Aktiengesetz, AktG) are not entitled to take part.

8. Miscellaneous

Recourse to legal action is not permitted.

Should a provision of these terms be or become invalid, this shall not affect the validity of the remaining provisions. The invalid provision shall be replaced by one which most closely represents the sense and purpose of the original provision. The same shall apply in the event of a legal loophole in these conditions of participation.

The place of performance and place of court of jurisdiction in Hanover, where an agreement regarding this is legally admissible.
